The Arizona Tax Credit is more than just a reduction in your tax liability; it's a reflection of your values within the community.

Since my son, Reece, first stepped foot into One Step Beyond for a tour, he has flourished. Now at 25, Reece wakes up bright and early every morning, excited to start his day at One Step Beyond. As Reece's needs have continued to evolve, One Step Beyond has consistently adapted to provide continual opportunities for growth and independence. For many adults who have disabilities, like Reece, it is easy to fall into patterns of inactivity that can curb progress, One Step Beyond empowers individuals and provides them with the means to get moving.

How can individuals claim the Arizona Tax Credit and is this program secure?

The transformative power of this credit cannot be overstated but the process is easy. Simply donate, turn in your receipt during your annual filing, fill out Arizona Form 321 or inform your tax professional, and you can get it right back to reduce your Arizona state tax liability by the same amount. Organizations must be certified by the Arizona Department of Revenue to be eligible, so rest assured that your contribution is going to a secure cause.

You don't need significant wealth to act, every cent you redirect is an investment. Just ten individual taxpayers utilizing the Arizona Tax Credit can collectively contribute over \$4000 to championing charitable organizations if they file before April 15, 2024.

As a taxpayer you have the chance to enrich lives and our communities, start with an organization that is meaningful to you.
